SW Sports Performance used a software call Typeform for all areas that require any data input – including medical information and personal information.

**Typeform** specializes in **online form building and online surveys**. It allows users to create dynamic forms and surveys without needing to write code.

Typeform takes the security and privacy of user data very seriously. Here are some key points about their security measures and compliance:

# 1. Certifications and Standards:

- Typeform's security and compliance framework is certified by several international standards, including:
  - **ISO 27001**: This standard focuses on managing the security of an organization's information. Typeform ensures the confidentiality, availability, and integrity of client data.
  - **ISO 27701**: An extension to ISO 27001, it establishes requirements for a Privacy Information Management System (PIMS) to protect personally identifiable information (PII).
  - SOC 2 Type II: Ensures secure management of customer data.
  - **HIPAA Type I**: Compliance with healthcare data protection regulations.
  - **GDPR**: The strictest international privacy regulation, mandatory for EU-based organizations.
